Approval of June 2023, Board Meeting Minutes

Warren Frary made a motion to approve the August 22, 2023, minutes as presented in the September 26, 2023 Board meeting packet. Raina Dawson seconded the motion. Motion carried.

Committee Reports

Finance Committee – George Monger

The committee met on September 18, 2023, to review August 2023 Financial Statements. Due to lack of a quorum at the meeting, no business decisions were made.

August 2023 Profit & Loss Statement (included in packet)

- OHMAS Outreach Grant is favorable with \$77,497.
- MHRSB Employee Retention & Recruiting was \$24,496 this month as grant money was \$100,000 (with the request to not return unused monies)
- Allocations \$121,380 on target with budget.
- Grant income includes Greater Toledo Community Foundation Care Fund.
- Total income for June was \$194,270, budgeted was \$139,541with \$54,729 over budget. YTD over budget by \$62,547.
- Payroll expense is up due unused vacation being paid out.
- Transportation is higher due to van repair –new tires and some minor repairs.
- Programs up as Supper Club is increasing.
- Total expenses were \$269,495, budget \$141,609 with \$70,157 amount over budget due to new server, advertising/marketing and annual maintenance. Makes \$29,883 over budget in expenses. YTD is \$125,278 over budget.

George Monger made a motion that Board of Trustees approve the August 2023, Financial Budget Statements as presented in the September 26, 2023 board meeting packet. Tim Cummins seconded the motion. Motion carried.

- Deborah stated there were six nominations for the two open Voting Member Elected positions on the board. She made a request for volunteers to work with her on interviewing these candidates for the board.
