


HISTORY OF TMWC

Who Is Thomas M. Wernert?

The Thomas M. Wernert Center is proudly named for a man who valued and advocated for the power of peer support in an individual's journey of mental health recovery. Thomas Wernert served as the Executive Director of the Lucas County Mental Health Board for more than 30 years. Throughout his career, he helped to establish Hospice of Northwest Ohio and oversaw the creation of other

mental health centers and recovery services for Lucas County residents.

Mr. Wernert worked closely with mental health consumers and advocates to ensure that consumer's rights and appropriate treatment were achieved. He believed in the power of peer support and that the connection among peers helps end feelings of isolation and stigma. As a result, he was the first to fund the Consumers Union of Lucas



County as a standalone agency through the Lucas County Mental Health Board.

During his time at the Mental Health Board, Mr. Wernert also hired and worked alongside Toledo's current mayor, Wade Kapszukiewicz. "He was a great boss and a great guy. Tom had a big heart with a big personality," says Mayor Wade. "I think about him a lot in my daily work now."

Mr. Wernert lost his battle with cancer in March 1999. His life work helped pave the way for recovery in Lucas County. The Consumers Union of Lucas County was renamed The Thomas M. Wernert Center in July 2004.



Make Your Vote Count for Mental Health


This month, we have an opportunity to make our voices heard and support mental health in our community by voting YES on Issue 8, during the primary election on March 19, 2024.

The Fair Housing Center is a nonprofit civil rights agency that promotes housing choice, the creation of inclusive communities of opportunity, and the protection and expansion of fair housing rights to support strong communities free from housing discrimination.

Local activists and media have recently been highlighting poor living conditions in central Toledo apartment buildings. However, housing discrimination is not always as obvious or apparent.
